- 4. News from the Practice:

LS informed the group of the latest developments at the surgery.

a - **SMS Text Messaging**. The service was switched on, on the 7th January, pts get a confirmation text immediately after booking appointment to confirm and then a reminder 48 hours before their appointment.

An "opt-out" slip is available at reception for patients to complete who do not wish to receive text message appointment reminders. Less than 10 patients have request to "Opt-Out" of receiving messages.

- b –NHS Health Checks 290 letters have been posted to patients inviting them for a NHS Health Check, 175 patients have booked appointments a 61% uptake rate. We will be continuing this scheme in the new financial year.
- c **-Patient Survey** this has been available to complete from the practice website since just before Christmas. The surveys are now available in the surgery for patients to complete. We have entered 70 surveys that patients have completed to the practice website from where the responses will be amalgamated in the background. The practice newsletter group have been contacted asking them if they would like to complete the survey.
- d-Section 106 monies the practice has been awarded some Section 106 monies to be used to increase capacity.
- e- The roof has been repaired after a leak was found in the waiting room
- f- New boilers have been installed.
